Patricio Abinales is associate professor at the Center for Southeast Asian Studies, Kyoto University. He is the author of *Images of State Power: Essays on Philippine Politics from the Margins* (UP Press, 1998) and editor of *The Revolution Falters: The Left in Philippine Politics after 1986* (Cornell University Southeast Asia Program, 1997). His manuscript *State Authority and Local Power in Southern Mindanao, 1900-1972* will be published by the Ateneo de Manila University Press.

Judy Celine Ick is a Shakespearean scholar and actress. She obtained her PhD in English from the University of Massachusetts at Amherst in 1994 on a Fulbright scholarship.
